Request from the EC and its Member States (hereinafter the EC)

<u>Indonesia</u>

General remarks

This request covers horizontal commitments, MFN exemptions and the following service sectors:

- Professional services
- Business services (other than professional services)
- Postal and courier services
- News agency services
- Telecommunications services
- Construction and related engineering services
- Distribution services
- Environmental services
- Financial services (banking, insurance, securities, other)
- Tourism and travel related services
- News agency services
- Transport (air, maritime, land, other) services
- Energy

The EC proposes that Indonesia's current GATS commitments are revised in accordance with this request. The EC is both seeking improved commitments and clarification of existing commitments as set out in this Request. The EC is furthermore looking for a reduction in scheduled limitations whether these are horizontal or sector specific in nature.

The EC further requests that commitments are entered in accordance with the scheduling guidelines adopted by the Council of Trade in Services on 23 March 2001 (S/L/92). In particular, for each commitment or limitation entered the EC requests:

- that any remaining limitation on market access (hereafter "MA") or on national treatment (hereafter "NT") are clearly described and only be inscribed in the market access or national treatment columns if the measure is of a nature foreseen by Articles XVI-XVII GATS.

The EC remains available to provide any clarification and answer any question on this request. Note: The EC reserves the right to revise and/or supplement this request. For each service sector, W120 classification has been followed unless expressly indicated and CPCs refer to the Provisional CPC classification. The precise scope for each sector is without prejudice to the EC's final positions on classification issues and to the EC's classification of their existing commitments.

HORIZONTAL COMMITMENTS

EC Request to Indonesia

Mode 3

- **Establishment of foreign firms** limited to joint ventures and/or representative offices. Joint ventures have a 49% foreign ownership limitation and required to be as Limited Liability Enterprise form. **EC request:** Remove limitations on foreign ownership and allow branches.
- **Non-resident tax-payers** are subject to withholding tax of 20% for repatriation of certain income (interests, dividend, royalties, dividend, fees). **EC request:** remove restrictions.
- **Acquisition of land (NT).** Foreigners not allowed to own land. Joint ventures may get building and rights of use, and may rent/lease land and property. **EC request:** Clarify how restrictions are currently applied.
- **The schedule** underlines (NT) that any juridical and natural personas should meet professional qualifications requirements. **EC request:** eliminate this discriminatory measure.

Mode 4

Intra-corporate transferees:

- Extent of commitment is not clear. **EC request**: Clarify scope of existing commitments in relation to Intra-corporate transferees (for example, in relation to the degree of affiliation which must exist between companies, permitted length of stay, prior employment/experience requirements, application of economic needs tests) explaining the relevant Labour and Immigration Laws and Regulations.
- Economic needs test applied to managers and technical experts. **EC** request: Eliminate.
- The EC also requests that a commitment be made to allow as intracorporate transferees without requiring an economic needs test « persons with a university degree or equivalent technical qualification who are transferring for career development purposes or to obtain training in business techniques or methods ». The maximum prior employment requirement should be one year.

Business Visitors:

- Extent of commitment is not clear. **EC request**: Clarify scope of existing commitment in relation to Business Visitors, in particular are Business Visitors who are not entering to themselves supply a service, but rather to either (a) establish a commercial presence or (b) negotiate and/or conclude salescontracts covered.

Contractual Service Suppliers:

- A contractual service supplier is either an individual service supplier or an employee of a service supplier, in both cases with no commercial presence

in Indonesia, but who has obtained a service contract in Indonesia which requires the presence of its employees in Indonesia to fulfil that contract. It is not clear whether this category of service supplier is covered under Indonesia's commitments. **EC request**: Clarify scope of existing commitments in relation to contractual service suppliers.

National treatment:

- Reference to «expatriate charges ». **EC request**: Clarify purpose and indicate to what extent the charges applied to foreigners differ from those applied to nationals.
- Requirement to hold a work permit. **EC request**: Clarify criteria used in considering applications for work permits.

Additional commitments.

- Difficulties are experienced as a result of the length of time taken to process permits and the specification applying to photographs which must accompany applications. The EC wishes to discuss the possibility of taking additional commitments to address these issues.

Note: Mode 4 is covered horizontally in this part for all service sectors. The sectoral requests in the following pages only refer to mode 4 when specifically related to one particular service sector.

PROFESSIONAL SERVICES

EC Request to Indonesia

Indonesia has committed this sector only partially. The EC requests that this sector is committed as follows:

a) Legal Services (CPC 861)

This sub-sector is not committed. **EC Request:**

- Commit covering at least consultancy on public international law and on law of jurisdiction where the service supplier or its personnel are qualified lawyers.
- Modes 1, 2, 3: Take full commitments, i.e. schedule "none" under MA and NT
- Mode 4: Commit as referred to in the section "Horizontal commitments"

b) Accounting, auditing and bookkeeping services (CPC 862)

This sub-sector is not committed. **EC Request:**

For accounting and bookkeeping services:

- Modes 1, 2, 3: Take full commitments, i.e. schedule "none" under MA and NT
- Mode 4: Commit as referred to in the section "Horizontal commitments"

For auditing services:

- Modes 2, 3: Take full commitments, i.e. schedule "none" under MA and NT
- Mode 4: Commit as referred to in the section "Horizontal commitments"

c) Taxation Services (CPC 863)

This sub-sector is not committed. **EC Request:**

- Modes 1, 2, 3: Take full commitments, i.e. schedule "none" under MA and NT
- Mode 4: Commit as referred to in the section "Horizontal commitments"

d) Architectural services (CPC 8671)

- Mode 1: MA and NT This mode remains unbound. **EC Request:** Take full commitments, i.e. schedule "none under MA and NT
- Mode 2: NT This mode remains unbound. **EC Request:** Take full commitments, i.e. schedule "none under NT
- Mode 3: MA Access restricted to joint operations or joint ventures. EC
 Request: Remove
- Mode 4: MA and NT This mode remains unbound. **EC Request:** Commit as referred to in the section "Horizontal commitments"

e) Engineering services (CPC 8672)

- This sub-sector is not committed for engineering design services (CPC 86726). **EC Request**: Extend sectoral coverage of commitments to this CPC
- Modes 1 and 2: MA These modes remain unbound for government funded projects as regards advisory and consultative engineering services (CPC 86721) and engineering design services for industrial processes and production (CPC 86725), and totally unbound for the rest of CPCs. EC Request: Take full commitments, i.e. schedule "none under MA and NT for the entire CPC 8672
- Modes 1 and 2: NT- These modes remain unbound. **EC Request:** Take full commitments, i.e. schedule "none" under MA and NT
- Mode 3: MA Access restricted to joint operations as regards advisory and consultative engineering services (CPC 86721) and engineering design services for industrial processes and production (CPC 86725), and restricted to joint operations or joint ventures for the rest of CPCs. EC Request: Remove

f) Integrated engineering services (CPC 8673)

- Mode 1: MA and NT This mode remains unbound. **EC Request:** Take full commitments, i.e. schedule "none", under MA and NT
- Mode 2: NT This mode remains unbound. **EC Request:** Take full commitments, i.e. schedule "none under NT
- Mode 3: MA Access restricted to joint operations or joint ventures. EC
 Request: Remove

g) Urban planning and landscape architectural services (CPC 8674)

- This sub-sector is committed only for urban planning services but refers instead to CPC 86742 (landscape architectural services). **EC Request:** Extend sectoral coverage of commitments to both urban planning services (CPC 86741) and landscape architectural services (CPC 86742)
- Mode 1: MA and NT This mode remains unbound. **EC Request:** Take full commitments, i.e. schedule "none" under MA and NT
- Mode 2: NT This mode remains unbound. **EC Request:** Take full commitments, i.e. schedule "none" under NT
- Mode 3: MA Access restricted to joint operations or joint ventures. EC
 Request: Remove

BUSINESS SERVICES (other than Professional Services)

EC Request to Indonesia

General:

For all sub-sectors where commitments have been taken:

Modes 1 and 2: MA – These modes remain unbound for government funded projects. Please clarify what the practical effect of this restriction is. The EC reserves the right to come back with a request in the light of Indonesia's response.

Modes 1 and 2: NT – These modes remain unbound. **EC request**: Take full commitments, i.e. schedule « none ».

Mode 3: MA – Form of establishment restriction. **EC request**: Eliminate.

Mode 3: NT – Licensing requirement for Indonesian joint operation partner. **EC request**: Eliminate.

Mode 4: MA – Commitment limited to directors and technical experts. **EC request**: Commit as referred to in the horizontal section.

B. Computer and Related Services:

General

This sub-sector has only been partially committed. **EC request**: Extend coverage and schedule commitments at the two-digit level as follows: Computer and Related Services (CPC 84):

Modes 1, 2 and 3: Take full commitments, i.e. schedule "none" under MA and NT:

Mode 4: Commit as referred to in the horizontal section.

In view of the rapid technological advances which have taken, and continue to take place, in this sub-sector, the EC proposes to seek clarification at a multilateral level as to what services are considered to be covered under CPC Prov 84.

C. Research and Development Services:

a. R&D Services on natural sciences (CPC 851) and

Indonesia has not committed this sub-Sector. The EC requests that it be committed as follows :

- Modes 1 and 3 : Take full commitments, i.e. schedule "none" under MA and NT.
- Mode 4: Commit as referred to in the section "Horizontal commitments".

c. Interdisciplinary R&D services. (CPC 853)

This sector has only been partially committed. **EC request**: Extend sectoral coverage to all of CPC 853.

See general request for Business services above.

D. Real Estate Services:

Indonesia has not committed this Sector. The EC requests that it be committed as follows:

- a. Involving own or leased property (CPC 821)
- b. On a fee or contract basis (CPC 822)

For each of the above sub-Sectors:

- Modes 1, 2, 3 : Take full commitments, i.e. schedule "none" under MA and NT
- Mode 4: Commit as referred to in the section "Horizontal commitments".

E. Rental and Leasing Services without Operators:

Indonesia has not committed this Sector. The EC requests that it be committed as follows:

- a. Relating to ships (CPC 83103)
- c. Relating to other transport equipment (CPC 83101 + 83102 + 83105)
- d. Relating to other machinery (CPC 83106 83109)

For each of the above sub-sectors:

- Modes 1, 2, 3 : Take full commitments, i.e. schedule "none" under MA and NT.
- Mode 4: Commit as referred to in the section "Horizontal commitments".

F. Other Business Services:

NB: Requests (if any) on (h) - services incidental to mining, and (j) - services incidental to energy distribution, are covered in those sections of the request dealing with Energy Services and Construction Services.

Translation Services (CPC 87905)

For each of the above sub-sectors :

- Mode 4: Commit as referred to in the section "Horizontal commitments".

I. Security Services (CPC 87302 – 87309)

Indonesia has not committed this sub-Sector. The EC requests that it be committed as follows :

- Mode 3 : MA Commit with no form of establishment or equity limitation. Full NT commitment i.e. schedule "none".
- Mode 4: Commit as referred to in the section "Horizontal commitments".

d. Services related to management consulting (CPC 866)

This sub-sector has only been committed for CPC 86601. **EC request**: extend sectoral coverage to all of CPC 866.

e. Technical testing and analysis services (CPC 8676)

See general request for Business Services above.

n. Maintenance and Repair of Equipment (not including transport equipment) (CPC 633 + 8861-8866)

This sub-sector does not appear to have been committed for CPC 8862-8865. The EC seeks clarification as to whether this is a typographical error. If this is

not the case, the EC requests that sectoral coverage be extended to CPCs 8862- 8865 as well.

POSTAL AND COURIER SERVICES

EC Request to Indonesia

This request includes sub-sectors that are listed under the negotiating proposal of the EC (S/CSS/W/61). The work on the revision of classification of this sector is still underway. For this reason, the sub-sectors lack reference to CPC.

Indonesia has not undertaken commitments in postal and courier services. The EC requests Indonesia to commit this sector as follows, based on the EC proposal for the revised classification of postal and courier services:

Services relating to the handling¹ of postal items², whether for domestic or foreign destinations:

A. Handling of addressed written communications on any kind of physical medium³, including:

- -Hybrid mail services
- -Direct mail
- B. Handling of addressed parcels and packages⁴
- C. Handling of addressed press products⁵
- D. Handling of items referred to in A. to C. above as registered or insured mail.
- E. Express delivery services for items referred to in A. to C. above.
- F. Handling of non-addressed items.
- G. Document exchange.
- H. Other services not elsewhere specified.

¹ The term "handling" should be taken to include clearance, sorting, transport and delivery.

³ E.g. letter, postcards.

⁴ Books, catalogues are included hereunder.

For sub-sectors B., C., E., F. and G.:

- Modes 1, 2 and 3: Undertake full commitments for market access and national treatment.
- Mode 4: Commit as referred to in the section « Horizontal commitments ».

For sub-sectors A. and D.:

- Modes 1, 2 and 3: Undertake commitments for market access and national treatment.
- Mode 4: Commit as referred to in the section « Horizontal commitments ».

NEWS AGENCY SERVICES

EC Request to Indonesia

Indonesia has not committed this sector (CPC 962). The EC requests that this Sector be committed as follows:

EC Request (CPC 962):

- Modes 1-3: Take full commitments, i.e. schedule "none" under MA and NT.
- Mode 4: Commit as referred to in the section "Horizontal commitments".

TELECOMMUNICATION SERVICES

EC Request to Indonesia

Indonesia has only partially committed this Sector. The EC requests that this Sector is committed as follows:

All Modes

There are no commitments in facsimile and private leased circuit services, Online Information and Data Base Retrieval, Electronic Data Interchange (EDI), Enhanced/Value-Added Facsimile Services and Code and Protocol Conversion. **EC request:** Make full commitments in all those sub-sectors, i.e. schedule "None".

Mode 1 - Cross-border supply

For local, long distance, international services, Packet-switched public data network, telex, telegraph, Mobile cellular telephone services, Internet Access services, Regional and National Paging and Public payphone services, this mode is unbound for national treatment. **EC request:** Make full commitments in all those sub-sectors, i.e. schedule "None" under National Treatment.

Mode 2 - Consumption abroad

For local, long distance, international services, Packet-switched public data network, telex, telegraph, Mobile cellular telephone services, Internet Access services, Regional and National Paging and Public payphone services, this mode is unbound for national treatment. **EC request:** Make full commitments in all those sub-sectors, i.e. schedule "None" under National Treatment.

Mode 3 - Establishment

- There are limitations on the number of operators:
 - Local services are provided exclusively by PT Telkom and 5 regional joint operation scheme operators. **EC request:** Remove this limitation.
 - Long distance services are provided exclusively by PT Telkom. **EC request:** Remove this limitation.
 - International services are provided exclusively by PT Indosat and PT Satelindo and Callback is not permitted. **EC request:** Remove these limitations.
 - For Mobile cellular telephone services, New entry is possible only through a joint venture with state-owned company. **EC request:** Remove this limitation.
 - For Electronic mail, Voice mail, Computer sharing services, Videotex services, Electronic mail box, File transfer services, and Home telemetering alarm, Access was granted to five foreign service provider companies, in addition to existing companies. **EC request:** Remove this restriction on the number of suppliers.

- For Packet-switched public data network, telex, telegraph, Internet Access services, Regional and National Paging and Public payphone services, a number of service suppliers is quoted, while there is no exclusion. **EC request:** suppress these mentions.
- There are limitations on the type of legal entity.
 - For local, long distance, international, and Public payphone services one of three Types of legal entity is required: Joint venture, Joint operation, or Contract management. **EC request:** Remove this limitation.
 - For Packet-switched public data network, telex, telegraph, Internet Access services, and Regional and National Paging Services one of two Types of legal entity is required: Joint venture or Joint operation. **EC request:** Remove this limitation.
 - For Mobile cellular telephone services a Joint venture is required. **EC request:** Remove this limitation.
- There are limitations on foreign ownership.
 - For local, long distance, international services, Packet-switched public data network, telex, telegraph, Mobile cellular telephone services, Internet Access services, Regional and National Paging and Public payphone services, Foreign equity participation is limited to 35 per cent. **EC request:** Remove this limitation.
- There are limitations on national treatment:
 - For Electronic mail, Voice mail, Computer sharing services, Videotex services, Electronic mail box, File transfer services, and Home telemetering alarm, Higher paid-up capital is required of foreign service suppliers than of domestic service suppliers. **EC request:** Remove this restriction.
- There are other restrictions scheduled under additional commitments:

The foreign service supplier must be a worldclass operator with extensive international experience. **EC request:** Remove this restriction.

The schedule states that all basic telecommunications services tariffs should be fixed by the government. **EC Request**: suppress this provision, the issue of maximum prices (if they are necessary) should be addressed by the universal service mechanism.

Mode 4 – Movement of natural persons

For local, long distance, international services, Packet-switched public data network, telex, telegraph, Mobile cellular telephone services, Internet Access

services, Regional and National Paging and Public payphone services, "Natural person for management and technical expert is limited to 20 persons." **EC Request**: suppress this restriction.

CONSTRUCTION AND RELATED ENGINEERING SERVICES

EC Request to Indonesia

<u>General</u>

Indonesia has committed this Sector only partially. The EC requests that this Sector be committed as follows:

All sub-sectors (CPC 511 to CPC 518)

- Mode 3: MA and NT – Restrictions on forms of establishment (Joint Operation and Joint Venture). **EC Request:** Remove these restrictions and schedule "none" under MA and NT.

A. General construction work for buildings (CPC 512)

This sub-sector is not committed for CPC 51210 (construction work for one- and two-dwelling buildings). **EC Request for this CPC:**

- Mode 3: Take full commitments, i.e. schedule "none" under MA and NT.
- Mode 4: Commit as referred in the section "Horizontal commitments".

C. Installation and assembly work (CPC 514+516)

This sub-sector is not committed for CPC 516. **EC Request for this CPC:**

- Mode 3: Take full commitments, i.e. schedule "none" under MA and NT.
- Mode 4: Commit as referred in the section "Horizontal commitments".

D. Building completion and finishing work (CPC 517)

This sub-sector is not committed. **EC Request:**

- Mode 3: Take full commitments, i.e. schedule "none" under MA and NT.
- Mode 4: Commit as referred in the section "Horizontal commitments".

E. Other (CPC 511+515+518)

- Extend commitments coverage to the whole sub-sector:
- Mode 3: Take full commitments, i.e. schedule "none" under MA and NT.
- Mode 4: Commit as referred in the section "Horizontal commitments".

MFN exemption

- Measures relating to preferential shortlisting. **EC request**: eliminate.

DISTRIBUTION SERVICES

EC Request to Indonesia

Indonesia has not committed this Sector. The EC requests that this Sector is committed as follows :

- A. Commission agents' services (CPC 621, 6111+6113+6121)
- B. Wholesale trade services (CPC 622, 6111+6113+6121)
- C. Retailing services (CPC 631+632, 6111+6113+6121+613)
- D. Franchising (CPC 8929)

- Modes 1, 2, 3: Take full commitments, i.e. schedule "none".
- Mode 4: Commit as referred in the section "Horizontal commitments".

Note: The EC is prepared to discuss exceptions for a very limited number of extremely sensitive goods, such as arms, ammunitions and explosives.

Note: In accordance with the W120 classification, the EC Request on "Repair services of personal and household goods" (CPC 633) is included under "1. Business services / F. Other business / n. Maintenance and repair".

ENVIRONMENTAL SERVICES

EC Request to Indonesia

Indonesia has not undertaken commitments in environmental services. The EC requests Indonesia to commit the following subsectors, based on the EC proposal for the classification of environmental services:

A. Water for human use & wastewater management

- Water collection, purification and distribution services through mains, except steam and hot water
- Waste water services (CPC 9401)

B. Solid/hazardous waste management

- Refuse disposal services (CPC 94020)
- Sanitation and similar services (CPC 94030)

C. Protection of ambient air and climate

- Services to reduce exhaust gases and other emissions and improve air quality (CPC 94040)

D. Remediation and cleanup of soil & water

 Treatment, remediation of contaminated/polluted soil and water (part of CPC 94060)

E. Noise & vibration abatement

- Noise abatement services (CPC 94050)

F. Protection of biodiversity and landscape

- Nature and landscape protection services (part of CPC 94060)

G. Other environmental & ancillary services

Other environmental protection services not classified elsewhere (CPC 94090)

- MA and NT Reciprocity condition. **EC Request**: Eliminate the reciprocity condition.
- MA and NT Horizontal MA limitation of 49% share capital in joint-ventures. **EC Request**: Remove this ceiling.

<u>Insurance</u>

- Modes 1 and 2: MA and NT MAT insurance. **EC Request**: Schedule according to Understanding.
- Modes 1 and 2: MA and NT Reinsurance and retrocession and services auxiliary to insurance. **EC Request**: Schedule according to Understanding.

- Modes 1 and 2: MA and NT Requirement for cross-border reinsurance to be subject to rating by a rating institution. **EC Request**: Remove this requirement.

- Modes 1 and 2: MA and NT Compulsory 10% cession of fire business to ReIndo. **EC Request**: Eliminate this compulsory cession.
- Mode 3: MA Establishment of wholly owned subsidiaries. **EC Request**: Take full commitments.
- Mode 3: MA Direct branching. **EC Request**: Commit direct branching.
- Mode 3: MA and NT Minimum risk detention on domestic market. **EC Request**: Eliminate this constraint.
- Mode 3: MA and NT Investment restrictions. **EC Request**: Remove those restrictions.
- Mode 3: MA and NT State monopolies on certain lines of insurance. **EC Request**: Open to competition.
- Mode 3: NT Discrimination against joint ventures in regulation enforcement, for example tax audits. **EC Request**: Eliminate the discrimination.

In this context Indonesia may wish to take the one or more of the following principles into concern:

- <u>Geographical limitations:</u> Transport of international cargo between ports within the same province/district/special region [or other relevant regional entity] remains excluded.

Efficient ground-handling is essential to the proper functioning of air transport and competition between operators in this area ensures that proper use is made of air transport infrastructure. It helps reduce the operating costs of airlines and improves the quality of service for airport users.

- Passenger Handling assisting arriving, departing and transfer passengers (CPC 7461);
